In the reference 7th read above, The K.N Educational Society, Regd.No.325/2009 of Vidya Nagar, Kurnool, has applied for according permission to grant of Provisional of Recognition for a period of 10 years from 2020-2021 to 2029-2030 for classes I to VII (EM) in respect of Monte School, Indus Nagar, Pandipadu (V), Kallur(NI) Kurnool District.

In the reference 8th read above, the inspecting Officer, i.e Mandal Educational Officer, Kallur has caused Inspection and submitted proposals with his recommendation report for grant of permission to grant of Provisional of Recognition for a period of 10years from 2020-21 to 2029-30 for classes I to VII (EM) in respect of Monte School. Indus Nagar, Pandipadu (V), Kallur(M) Kurnool District.

After careful examination of the proposals from the society, and also the inspection report of the inspecting officer in the reference 1st to 4th read above, under rule 3(i)(a) of GO 1st read above, permission here by accorded for grant of Provisional of Recognition ion for classes I to VII (EM&TM) from the year 2020-2021 to 2029-2030 (10Years) in respect of Monte School, Indus Nagar, Pandipadu (V), Kallur(M) Kurnool District subject to fulfillment of the following conditions.

That the Educational Institutions shall serve the needs of the locality more particularly.

- 1. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- That the school timing vacations and mid term holidays shall be followed as prescribed by Government from time to time.
- That the qualified staff within the age limits prescribed by Government employees shall be appointed with the management own funds as per staff pattern.
- That the results of institution shall be satisfactory every year.
- That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- That the list of Governing Body shall be furnished to the District Educational Officer every year.
- That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
- That the school shall not be remained closed without giving notice both to the parents / District Educational Officer, and competent authority at least six months before.
- 10. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 11. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the Provisional recognition now granted.
- That the society shall provide fire safety measures in the school as per the No objection certificate / advise of the Fire Services Department authorities.immedetely
- 13. The management is informed that no thatched roof accommodation is allowed to run the school.
- 14. Proper and adequate sanitation facility shall be provided for students especially for girl students.

- 15. The school shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
- 16. The school shall follow the traffic and safety guidelines indicated by the police and fire services, Departments.
- 17. The parent teachers associations meeting should be conducted to sensitize the parents on the safety of the children and also for the various health concerns of their children.
- 13. The school shall have first aid kit and the teachers shall be trained in first aid,
- 19. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time without fail.
- 20. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
- 21. That the management shall take every responsibility for the timely, safe and comfortable mobility of the School Children from the residences to School and vice versa.
- 22. That the School Van if any should be ensured road worthy for the transportation mobility of school children
- 23. That the school van should be free from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
- 24. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans if any.
- 25. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles if any without fail.
- 25. That management shall ensure the accounts of the school audited by an authorized chartered accountable every year and submit.
- 27. The management shall have to follow the rules and guidelines issued to Go.Ms.No.91, Edn., Dt.06.08.2009 regarding fee structure in private Schools.
- 28. The management shall have to follow the G.O Ms.No.01 and subsequent G.Os / memos issued from time to time without any deviation.
- 29. That the management shall not run any Pre-primary classes other than those now permitted and also shall not run hostel.
- 30. That the management shall ensure all the children studying in their school shall be brought in to child info without fail.
- 31. That the Management shall maintain / provide required fire extinguishers in the school premises.
- 32. That the Management shall ensure for the regular health check up of the school children periodically or d shall coordinate with the Medical & Health Department authorities concerned without fail.
- 33. Any deviation of the norms / guidelines issued from time to time will be viewed seriously.
- 34. Structural soundness Certificate and Sanitary Certificate should be obtained for the renewal period. Receipt of these proceedings should be acknowledged.
